- Doctorate in Chemistry.
- Experience in research in the field of organic chemistry, with a particular focus on asymmetric synthesis and organocatalysis, documented by publications.
- Experience in the synthesis of chiral carbo- and heterocyclic compounds.
- Knowledge of spectroscopic methods and their use for the identification of organic compounds.
- Knowledge of specialized research techniques such as: NMR, MS, HPLC, UPCC.
- Scientific achievement in the field of asymmetric organocatalysis documented by publication, including review articles.
- The ability to search chemical literature using modern databases, such as Reaxys, SciFinder, czy Scopus.
- Proficient knowledge of Polish in speech and writing, good knowledge of English.
- Teaching experience in conducting classes with students and in scientific care of diplomats in the field of organic chemistry.
- Ability to plan and organize experimental work on your own.
- Experience in preparing manuscripts of publications, including review articles.
- Ability to work in a team.
- Strong motivation and enthusiasm for research and further scientific development.
