- teaching experience, including classes with students and scientific supervision of students' diploma theses in the field of analytical chemistry;
- the ability to search chemical literature using modern databases, such as SciFinder or Scopus;

Data Privacy Statement for job candidates

- 1) Lodz University of Technology with the registered office in Lodz is the Controller of your personal data;

- 3) As the controller, we will process your data for the purpose of the recruitment process for the position indicated, based on your consent (Article 6(1)(a) GDPR);
